INSURANCE	<p>All the competitors compete and train on their own risk, so please make sure that your gymnasts have insurance policy.</p> <p>The Host Federation and the LOC will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>Delegation members with insufficient insurance cover must inform the LOC in advance.</p>
INTERNATIONAL TRANSPORTATION	<p>Each team has to pay for their own travel expenses.</p> <p>The Travel Schedule Form must be returned to the LOC with Nominative registration till April 1st 2017.</p>
LOCAL TRANSPORTATION	<p>Local transport from Jože Pučnik Ljubljana Airport or Train and Bus station Ljubljana to the hotel, competition venues and city will be provide free of charge by the LOC.</p>
