FEDERATIONS INVITED	The Organizing Member Federation will invite all Member Federations according to the following principles: all FIG Member Federation in good standing.
AGE LIMITS	WAG: Junior gymnast: 13-15 years (born in 2000 – 2003), with valid FIG licence. The team is composed from 3 girls (3,3,2).
JUDGES AND JURIES	Each Federation or club is obligate to provide 1 judge.
REGISTRATION DEADLINES	Definitive registration: February 28 <sup>th</sup> , 2015
	Nominative registration April 15 <sup>th</sup> , 2015
ENTRY FEES	<p>The Entry fee for this event will be: 50 EUR for every person in the team (3 girls and the coach).</p> <p>The fee covers the costs for :</p> <ul style="list-style-type: none"> <li>- lodging and meals from May, 29<sup>th</sup> till May, 31<sup>st</sup> 2015 for : <ul style="list-style-type: none"> <li>3 girls (competitors)</li> <li>1 coach</li> <li>1 judge</li> </ul> </li> <li>- transfer from the airport or train station to the hotel and back and all the transfers to the gym hall and back.</li> </ul> <p>All the costs for the judges will be paid by the organizer. Each team must pay the expences for any extra person (100 EUR per person).</p> <p><b><i>We will accept the first 20 teams who will register and maximum 3 per country, because the it is imposible to organize competition for more than 20 teams. There is also a maximum of 3 gymnast per club.</i></b></p>
ACCREDITATION	Will be held during the arrival day at the competition hall.
EVENT FORMAT	Team and all around competition - modification rules for juniors

MEDICAL SERVICES	Medical services provided during the competition.
VISA	<p>Please verify immediately with your travel agent or the Slovenian Embassy or Consulate in your country if a visa is required for your travel to Slovenia. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before April 15<sup>th</sup> 2015 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary



	<p>valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p>														
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations/clubs must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by April 15<sup>th</sup> 2015.</p>														
LOCAL TRANSPORTATION	<p>The transportation from/to airport or the railway/bus station will be arranged by the LOC. The Entry for the team (3 girls and the coach). covers also the costs for: transfer from the airport or train station to the hotel and back and all the transfers to the gym hall and back.</p> <p>The Travel Schedule Form must be returned to the LOC by April 15<sup>th</sup> 2015.</p>


