FEDERATIONS INVITED	The Organizing Member Federation will invite all Member Federations according to the following principles: all FIG Member Federation in good standing.			
AGE LIMITS	WAG: Junior gymnast: 13-15 years (born in 2000 – 2003), with valid FIG licence. The team is composed from 3 girls (3,3,2).			
JUDGES AND JURIES	Each Federation or club is obligate to provide 1 judge.			
REGISTRATION DEADLINES	Definitive registration:	February 28 <sup>th</sup> , 2015		
	Nominative registration	April 15 <sup>th</sup> , 2015		
ENTRY FEES	The Entry fee for this event will be: 50 EUR for every person in the team (3 girls and the coach).  The fee covers the costs for:  - lodging and meals from May, 29th till May, 31st 2015 for:  3 girls (competitors)  1 coach  1 judge  - transfer from the airport or train station to the hotel and back and all the transfers to the gym hall and back.  All the costs for the judges will be payed by the organizer.  Each team must pay the expences for any extra person (100 EUR per person).  We will accept the first 20 teams who will register and maximum 3 per country, because the it is inposible to organize competition for more than 20 teams. There is also a maximum of 3 gymnast per club.			
ACCREDITATION	Will be held during the arrival day at the competition hall.

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.			
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.
